

Provider Notification Tool

This tool allows:

1. PCPs and referring providers to be notified when their patient has an event at an HCA Healthcare hospital
2. Specialists to be notified when a patient is referred to from our hospitals' ER
3. PCPs, referring, and consulting providers to receive a direct message when their patient has an ADT event at our hospital*

Delivery & Timing

- New!** For the highlighted events, direct messages* are auto-sent in real time to the PCP, referring, and consulting providers with an EMR published direct address
- Email: Batched or hourly notifications offered
- Fax: Hourly
- Text: 15 minutes after patient referral occurs
- Secondary Provider and up to 3 Proxy designations available
- Option to stop notifications while out of the office

Additional Details

- Patients must identify their PCP and/or referring physician during registration/admission for the notification to be sent.
- The ER provider must choose the specialist to refer to during the discharge routine.
- Text notifications will be sent as a HIPAA compliant message with the patient's first three letters of their last name and the first two letters of their first name.
- Email and fax notifications include full patient details. Emails are encrypted.



*This supports CMS Conditions of Participation Requirement §482.13(b)(4), giving patients the right to have a family member or representative of his or her choice and his or her own physician notified promptly of his or her admission to the hospital.

NEW: Direct message notification example

PCPs, Referring, and Consulting are auto-enrolled if direct address is published with a HISP

Patient (NAME, DOB, ADDRESS) was admitted to FACILITY on DATE at TIME. PATIENT NAME has requested that PCP NAME be notified of the inpatient admission. This is an auto generated notification. DO NOT REPLY directly to this message as replies are not monitored from this address and will not be returned.

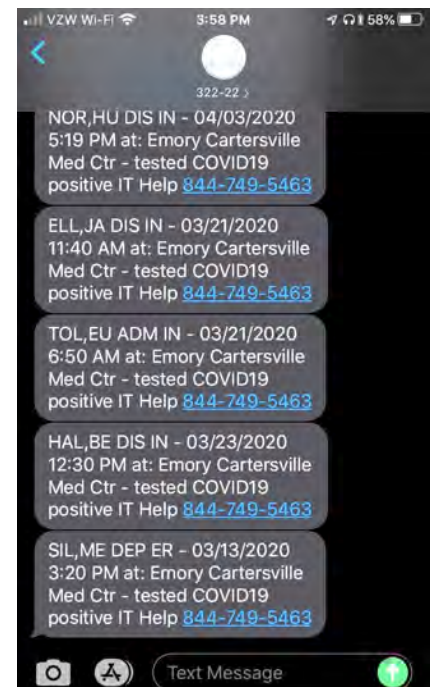
